EXECUTIVE SUMMARY

This work is part of the Work Package 4 (WP4: Scientific resources usable by visually impaired: text books, lessons, examinations). Regulations concerning intellectual property and copyright may affect distribution as well as adaptation of documents to be read by blind and partially sighted readers. Therefore this work aims to analyze copyright regulations in order to make clear in which countries and under which circumstances reading resources can be adapted and distributed to blind or partially sighted students. At first the European Copyright Directive is introduced. Subsequently, is analyzed the application of the European Copyright Directive in most European countries, with respect to provisions for people with disability. Then, some success experiences in delivering copyrighted works to people with visual impairment are introduced. The following sections concern distribution modalities oriented to open access repositories which turn to be useful for individuals as well as public or private institutions which adapt and distribute content to people with visual impairment. In particular, since scientific papers and journals are essential in science learning and in scientific research, distribution of these resources is addressed by illustrating both delivery modalities and success experiences.

1 INTRODUCTION

All the institutions, associations and companies which work to adapt and deliver reading resources for the use of blind or partially sighted readers have to manage issues concerning copyright. Regulation about copyright has been evolving all over the world for years. In Europe, in 2001 was enacted the Directive 2001/29/EC of the European Parliament and of the Council of 22 May 2001 (EUCD) on the harmonisation of certain aspects of copyright and related rights in the information society. This directive concerns the legal protection of copyright and related rights in the framework of the internal European market, with particular emphasis on the information society. Today, years after intense debates, almost all EU member states have transposed the EU-Copyright Directive into national law. However, the continuing controversies surrounding the EUCD itself and conflicts about the national implementations have made clear that we are far from having reached a consensus about the appropriate design of copyright law for the digital age that satisfies the interests of all relevant stakeholders, including content producers, teachers, students, and the public at large. Scientific communication is undertaking new strategies of knowledge dissemination, which comply with author's right. These strategies are based on the Open Access Initiative. Section 4 will introduce this initiative and benefits emerging for blind and partially sighted readers.

2 THE EUROPEAN COPYRIGHT DIRECTIVE

This section analyses the European Copyright Directive with respect to the possibility to deliver copyrighted content to blind and partially sighted persons.

The EUCD provides authors for three basic rights: reproduction right, right of communication to the public of works and of making available to the public other subject-matter and distribution right. These three rights are set out as follows in articles II.2, II.3 and II.4:

2.1 Article 2

Reproduction right

Member States shall provide for the exclusive right to authorise or prohibit direct or indirect, temporary or permanent reproduction by any means and in any form, in whole or in part:

- a. for authors, of their works;
- b. for performers, of fixations of their performances;
- c. for phonogram producers, of their phonograms;
- d. for the producers of the first fixations of films, in respect of the original and copies of their films;
- e. for broadcasting organisations, of fixations of their broadcasts, whether those broadcasts are transmitted by wire or over the air, including by cable or satellite.

2.2 Article 3

Right of communication to the public of works and right of making available to the public other subject-matter

1. Member States shall provide authors with the exclusive right to authorise or prohibit any communication to the public of their works, by wire or wireless means, including the making available to the public of their works in such a way that members of the public may access them from a place and at a time individually chosen by them.
2. Member States shall provide for the exclusive right to authorise or prohibit the making available to the public, by wire or wireless means, in such a way that members of the public may access them from a place and at a time individually chosen by them:
 - a. for performers, of fixations of their performances;
 - b. for phonogram producers, of their phonograms;

- c. for the producers of the first fixations of films, of the original and copies of their films;
 - d. for broadcasting organisations, of fixations of their broadcasts, whether these broadcasts are transmitted by wire or over the air, including by cable or satellite.
3. The rights referred to in paragraphs 1 and 2 shall not be exhausted by any act of communication to the public or making available to the public as set out in this Article.

2.3 Article 4

Distribution right

1. Member States shall provide for authors, in respect of the original of their works or of copies thereof, the exclusive right to authorise or prohibit any form of distribution to the public by sale or otherwise.
2. The distribution right shall not be exhausted within the Community in respect of the original or copies of the work, except where the first sale or other transfer of ownership in the Community of that object is made by the right holder or with his consent.
3. EUCD allows for some exceptions and limitations to reproduction, communication and distribution rights. In particular, the following provisions concerning exceptions and limitations are of special interest to deliver content to blind and partially sighted. First of all, Recitals 34 and 43 emphasize the need for exceptions, especially for facilitating learning and for the benefit of people with disability.
 - (34) Member States should be given the option of providing for certain exceptions or limitations for cases such as educational and scientific purposes, for the benefit of public institutions such as libraries and archives, for purposes of news reporting, for quotations, for use by people with disabilities, for public security uses and for uses in administrative and judicial proceedings.
 - (43) It is in any case important for the Member States to adopt all necessary measures to facilitate access to works by persons suffering from a disability which constitutes an obstacle to the use of the works themselves, and to pay particular attention to accessible formats.

2.4 Article 5

Article 5 requires member states to allow for exceptions to reproduction, communication and distribution rights, in particular as for cultural, research and teaching activities and people with disability.

Article II.5.2(c)

Member States may provide for exceptions or limitations to the reproduction right provided for in Article 2 in the following cases:

- (c) in respect of specific acts of reproduction made by publicly accessible libraries, educational establishments or museums, or by archives, which are not for direct or indirect economic or commercial advantage.

Article II.5.3

Member States may provide for exceptions or limitations to the rights provided for in Articles 2 and 3 in the following cases:

- (a) use for the sole purpose of illustration for teaching or scientific research, as long as the source, including the author's name, is indicated, unless this turns out to be impossible and to the extent justified by the non-commercial purpose to be achieved;
- (b) uses, for the benefit of people with a disability, which are directly related to the disability and of a non-commercial nature, to the extent required by the specific disability;
- (n) use by communication or making available, for the purpose of research or private study, to individual members of the public by dedicated terminals on the premises of establishments referred to in paragraph 2(c) of works and other subject-matter not subject to purchase or licensing terms which are contained in their collections.

Article II.5.4

Where the Member States may provide for an exception or limitation to the right of reproduction pursuant to paragraphs 2 and 3, they may provide similarly for an exception or limitation to the right of distribution as referred to in Article 4 to the extent justified by the purpose of the authorised act of reproduction.

The implementation of EUCD provisions in EU member states went through many controversies. The following section illustrates how EUCD was implemented in member states, especially with respect to exceptions and limitations which can facilitate the reproduction and distribution of digital content to blind and partially sighted.

3 APPLICATION OF THE EUROPEAN COPYRIGHT DIRECTIVE

3.1 Introduction

Up to now, the European Copyright Directive has been transposed in almost all member states. The following sections will illustrate in particular how were implemented:

- Exceptions and limitations for people with disability;
- Exceptions and limitations for learning purposes;
- Exceptions and limitations for libraries and educational establishments.

3.2 Austria

The directive was implemented into Austrian law in April 2003. The EU directive uses the term “copyright”, whereas in Austria and in Germany there is a distinction between author's rights and derivative exploitation rights.

Author's right cannot be removed or sold and is therefore inalienably linked to the author. Exploitation rights can be negotiated. Exceptions and limitations concerning making copies and distributing copyrighted works are analyzed. It is generally not allowed, unless the rights holder authorizes it (in subsection 8 the law says “only with the consent of the rights holder”) to copy whole books, whole magazines or sheet music; even when the copy is produced from another copy. An exception holds for not published or out of print works. An entirely new provision, laid down in section 42d, concerns special rights for persons with disability: it is now explicitly allowed to copy and distribute copyrighted works for disabled people, who would otherwise have no or only limited access to those works. However, that must be done not for commercial purposes, which actually limits this right. There are also problems with the provisions in subsection 2, where it says the author has the right to an “appropriate compensation” for copies even under this regulation. In practice, individuals as well as whatever institution, association or company which will recourse to this right will have to look for a fair balance between the obligation not to act commercially on the one hand and the royalties to pay to the rights holder as “appropriate compensation” on the others. Also, Austrian lawmakers have not introduced, as their German colleagues have, a regulation obliging rights holders to lift copy protection mechanisms for the purpose of producing copies of a copyright work on a medium legible for disabled persons. That means for example that law infringement may occur in trying to adapt copyrighted works protected by copy protection mechanisms or DRM systems. Since many digital resources are going to be protected, special agreements with rights holder have to be reached before adapting. So, the lack of a specific provision may slow down the production of digital resources accessible for disabled people.

As for copy regulations for public institutions, Section 42, Subsection 6 deals with provisions for schools and universities, which may produce copies of copyrighted works in the following cases:

- copies for teaching purposes;
- copies on paper or a similar matter.

According to subsection 7 of the same section, public archives and libraries, which were formerly simply allowed to produce copies for their own non-commercial ends, will have to observe some restrictions in the future. They may still produce copies on paper or a similar matter indiscriminately, but in contrast to the former regulation, copies on any other media (e.g. digital copies) may be produced only for non-commercial ends. Furthermore, the work must be in possession. For all copies, the following conditions must apply:

- one single copy may be produced of own pieces of work; this copy may be exhibited, lent or used under same provisions as the original;
- just like private persons, libraries and archives may produce single copies of works which have not been published or are out of print; the same provisions on exhibiting, lending and using the work apply to these copies as to the original work.

3.3 Belgium

The Belgian Copyright Act of June 30, 1994 was amended by the act of May 22, 2005, which transposed the EUCD into Belgian law. As for exceptions for people with disability, Belgian law allows reproduction and distribution, provided that the use may not conflict with the normal exploitation of the work and may not unreasonably prejudice the legitimate interests of the rightholders (Article 22.1(11)). As for exceptions for libraries and educational establishments, provisions are set out in Article 22(1)(8). Educational establishments can reproduce works limited to number of copies necessary for preservation of cultural and scientific patrimony. There must be No conflict with normal exploitation and no unreasonable prejudice of the legitimate interest of the author. Copies are property of museum, library or archive.

3.4 Denmark

The Directive was implemented in Danish legislation as a revision of the existing Danish law on intellectual property right. The Danish Copyright Act (Consolidated Act No. 164 of March 12, 2003) transposes the provisions of the EUCD into Danish national law. General EUCD provisions concerning reproduction, communication and distribution of copyrighted content are transposed in Danish law as they are addressed in EUCD.

In particular, some exceptions and limitations are remarkable. Reproduction within archives, libraries and museums is allowed if concerned with their activities and if not done for commercial purposes. By the way, if the copies are done in digital form, the copies may not without the consent of the author be lent or in any other way be made available to the public outside the archives, libraries or museums.

A new legal licence to allow libraries to distribute articles and text excerpts to their users in digital form (by e-mail, through authorized remote connection, etc.) was introduced.

As for exceptions for people with disability, it is permitted to use and distribute copies of published works if the use and the distributed copies are specifically intended for the blind, visually impaired, the deaf and sufferers from speech impediments, and besides persons who on account of a

handicap are unable to read printed text. This exception shall not apply to the use or distribution of copies for commercial purposes.

Circumvention of technological measures to protect copyrighted works to the purpose of making works available for people with disability is addressed by Danish law. In article 6.4 of the directive the starting point is that rights holders should make it possible for users that are covered by the exceptions in section 2 to make use of the exceptions. One way of doing this is through an agreement between the rights holders and the group of users covered by the exception (i.e. disabled people). If an agreement can not be reached section 75(d) of the Danish law gives the users (and the rights holder) a right to take the case to an administrative body: The Board for Intellectual Property Rights. The board can instruct the rights owner to make the works available for the affected group of users in a form that allows the users to make use of the exception. How this should be done will be decided on a case-by-case basis: by making cryptographic keys available, by making the work available in non-digital form, by making decryption devices available etc.

3.5 France

In August 2006 the French Parliament approved the French transposition of EUCD: DADVSI. Article L-122-5 states that reproduction or communication of copyrighted works are allowed for private use by disabled people. Disability must be motorial, mental, sensorial, psychological, cognitive or physical, should amount to a rate to be determined by the Conseil d'Etat, and should be recognised by a specialised commission or a medical certificate. Reproduction and representation by a legal entity or publicly open establishments is permitted. The list of eligible institutions is determined by the authorities. Publishers will have obligation to provide their digital files to any certified organism producing alternate books and material for the blind or/and handicapped people. Article L-1225-8 sets out exception provisions for educational establishments and libraries. Educational establishments and libraries can reproduce works to the purpose of preservation or on site consultation.

3.6 Germany

The German Copyright Act of September 9, 1965, amended on September 10, 2003 implements the provisions of the EUCD.

In accordance with Article 5 of the EUCD, the German law introduces a number of exceptions and limitations to the exclusive rights to reproduce, to communicate and to make available to the public a work. These exceptions are laid down in part 6137. Copyrighted works can be copied, in particular, in the following circumstances:

- for persons with a disability, in order to enable them to access a work (section 45a). This section is the first provision of the German Copyright Act to be specifically designed for the needs of persons with disabilities. It thus honours Article 3 of the German Constitution, which states that no person shall be disfavoured on the basis of disability. Section 45a permits the reproduction of protected subject matter, such as the recording of works, for the benefit of blind persons, to the extent required by the specific disability. As far as

reproduction exceeds a small number of copies, paragraph 2 entitles rightholders to an appropriate compensation which claim is to be exercised by a collecting society;

- for educational and research purposes . The likewise new Section 52a deals with a specific limitation to the right of making available to the public. Section 52a [1] allows the making available of protected subject matter, which has been published, to certain distinct groups of persons if and to the extent where this is necessary for certain teaching or research purposes. Examples include the use in on-line classes or access-controlled parts of a university's intranet. With this provision, the German legislature has made use of Article 5.3(a) of the Copyright Directive which entitles Member States to create exemptions for the benefit of educational or scientific uses. Paragraph 4 of Section 52a compensates rightholders with an appropriate remuneration which is to be claimed by a collecting society. The new exception on the right of making available is subject to various restrictions, due to lobbying by publishing companies and film producers. So has the extent to which protected materials can be made available been delimited to "small parts of a work", "works of small size" and "single contributions from newspapers and periodicals". Moreover, the number of beneficiaries has been confined to those institutions that are expressly mentioned. Finally, section 52(a) exempts expressly school books.

3.7 Ireland

Ireland transposed the EUCD with the amendment of the Statutory Instrument No. 16 of 2004 to the Irish Copyright and Related Rights. Exception provisions for disabled persons are set out in Article 104. Bodies designated by the Minister are entitle to reproduce and adapt copyrighted works to meet the specific needs of a disabled person. These bodies are also entitled to supply the modified copy to the disabled person. If the modified copy is subsequently made available to the public it is treated as an infringing copy. Articles 53-58 and Secs. 59 concern exceptions for educational establishments and libraries. Only educational establishments are entitled to reproduction exception for teaching purposes.

3.8 Italy

Italy transposed the EUCD in Legislative Decree of April 9th, 2003, no. 68: Implementation of the Directive 2001/29/EC on the harmonisation of certain aspects of copyright and related rights in the information society. This law, in particular provides for some exceptions to general provisions on reproduction, communication and distribution rights:

- Article 71-bis (1) states that people with disability are authorised, for their own personal use, to reproduce as well as to communicate to the public copyrighted works, for non-commercial purposes;
- in Article 71-quinquies(1) rights holders are required to adopt suitable solutions and agreements, to allow people and institutions to obtain the exceptions they are entitled to (for example, to allow visually impaired people to reproduce a protected e-book using a different format, in order to process it with a speech synthesiser or Braille display). Nobody,

however, is allowed to circumvent TPMs, even if they forbid, for example, making a private copy as well as access to people with disability.

3.9 Norway

On 17 June 2005, the Norwegian Parliament passed the Act implementing the EU Copyright Directive into Norwegian law. Article 17 provides exceptions for people with disability. Exceptions are set out for literary or scientific works or musical works as copies in other form than sound recordings for blind and visually impaired people or persons otherwise unable to enjoy the work in the usual way due to a disability. Reproduction on film with or without sound for those with impaired hearing or ability to speak are permitted. The government may license organisations or libraries to reproduce a published literary or scientific work by making a fixation on a device that can reproduce them for the purpose of free use by disabled people. Right holder is entitled to receive remuneration. Article 16 provides exceptions for libraries. Libraries are allowed to make copies for purposes of conserving and securing their collections. More specific qualification of this limitation will depend on the contractual arrangements with the right holder's organisation, and no such contract has so far been concluded.

3.10 Spain

As of 2006 provisions of copyright law are contained in Book One of the Intellectual Property Law of 11 November 1987 as modified. An exception for people with disability is contained in Article 31bis(3). It states that communication to the public, reproduction and distribution are not subject to authorization when these acts are undertaken for the benefit of people with a disability and are directly related to the disability and of a non-commercial nature, to the extent required by the specific disability. Article 37 (3) sets out exceptions for libraries and educational establishments. Reproduction of published works is permitted to libraries for no gainful interest. Educational establishments are excluded from this exception.

3.11 Slovakia

EUCD was transposed in Slovakia in Act No. 618/2003 of 4th December 2003. Exceptions to reproduction, communication and distribution rights for people with disability are set out in section 29(1). The authorisation of an author shall not be required to make a copy of a disclosed work, for its distribution to the public by any other form of transfer of ownership than sale, for its distribution to the public by lending or for communication to the public, provided such use is being exclusively realised to cater the needs of handicapped to the extent justified by their handicap and is not being realised to gain any direct or indirect economic advantage. Moreover, an exception for Libraries and archives. A library or archive may make without the authorisation of the author a copy, of the work from its own collections, provided the purpose of the making of a copy is to satisfy the request of a natural person who will use that copy for the purpose of education or scientific research exclusively within the premises of library or archive.

3.12 Sweden

EUCD was transposed into Swedish Law in May 2005. Provisions for disabled persons are set out in Article 17. Reproduction is permitted for the exploitation through Braille devices and speech synthesizers. Sound recordings and already available talking books are excluded from reproduction exception. Right-holders are entitled to remuneration. Only libraries and organizations with special permission from the government are allowed to produce talking books freely from paper books, to communicate copies through a network directly to disabled people and to make copies of radio or TV broadcasts and films for people who are deaf or hearing-impaired.

3.13 The Netherlands

EUCD was transposed into Dutch law in 2004 by amending The Dutch Copyright Act of 1912. Provisions about exceptions and limitations for people with disability are set out in Article 15. Although reproduction and distribution is permitted to enable people with disability to access copyrighted works, fair compensation is mandatory. In Article 16 there are provisions for libraries and educational establishments. Reproduction for the purpose of archiving, restoring or replacing the work in case of imminent destruction, or keeping it consultable when there is no technology available to render it is permitted. No regulation about document delivery and interlibrary loan has been set out up to now.

3.14 United Kingdom

The UK transposed the provisions of the EUCD with an amendment (The Copyright and Related Rights Regulation 2003) to the Copyright, Designs, and Patents Act 1988. An exception to reproduction and distribution rights is set out in Article 31A-31F. Reproduction and distribution are permitted only for visually impaired and people who are unable, through physical disability, to hold or manipulate a book or to focus or move their eyes to the extent that would normally be acceptable for reading, recordings of performances are excluded, provided that the work used is not available in the desired form. No distribution outside United Kingdom is permitted. Paragraph 5.2 (c) permits specific copying by publicly accessible libraries, educational establishments or museums, or by archives, which are not for direct or indirect economic or commercial advantage. Paragraph 5.3(a) permits use for the sole purpose of illustration for teaching or scientific research.

3.15 Summary

3.15.1 Introduction

National transpositions of the European Copyright Directive, in particular as for how exceptions are covered, are not homogenous. Furthermore, some essential matters, such as reproduction of works in digital formats, are not addressed by all countries or different provisions are set out. In some countries (e.g. United Kingdom) transnational distribution of copyrighted works adapted for people with disability is explicitly forbidden. These factors do not facilitate transnational distribution of copyrighted works by educational institutions and libraries, even as far as people with disability

are concerned. Therefore, in order to achieve transnational reproduction and distribution of copyrighted digital content, two ways are proposed:

- case-by-case agreements have to be negotiated with right-holders. Model agreements can be developed and proposed to right-holders, based on success experience (see section 4);
- collaboration actions with publisher associations are needed both to make them better understand problems concerning access to digital resources for people with disability and to make specialist organizations acquire knowledge about publishers' policies and internal workflow.

The two following subsections will contribute to argue these conclusions by summing up problems concerning national transpositions of EUCD with respect to exceptions and limitations.

3.15.2 Exceptions for archives and libraries

In the context of the EUCD and with regard to the transition from an analog/offline to a digital/online environment, two issues have been particularly contested: the making of digital copies of materials held in the library's collection, and electronic document delivery services.

Art. 5.2(c) EUCD states that member states may allow publicly accessible libraries, educational establishments or museums, or archives to make specific acts of reproduction, which are not for direct or indirect economic or commercial advantage. While the scope of the exception might be broader, the next paragraphs focus on copies for preservation or replacement purposes only. Among the challenges faced in national transpositions there is the problem of defining the exception's beneficiaries. Some countries, have simply replicated the wording of Art. 5.2(c) EUCD (e.g., France). Obviously, these implementations do not provide further guidance regarding the four - partly overlapping - types of institutions listed in Art. 5.2(c) EUCD. Similarly, it remains an open question as to what extent, for instance, university libraries (being often not entirely open to the public) fall within the scope of the privilege. Other countries, in contrast, have used more precise language. Some have further specified the institutions that benefit from the exception while others narrowed down the number of beneficiaries (e.g. Slovakia). A third way is to leave the definition of the beneficiaries for governmental agencies (e.g. Ireland).

A second question relates to the types of permissible reproductions. Some countries has implemented Art. 5.2(c) EUCD with respect to any kind of reproductions, including digital or analog works (e.g. France). Other countries (e.g., Italy) restricted their implementation to analog copies. Generally, countries require that copies can be made exclusively for the purposes of preservation and replacement of works (e.g. Slovakia). In addition, some countries explicitly allow beneficiaries to distribute these copies to similar institutions (e.g. United Kingdom). In other cases, giving copies of works to other institutions is permitted if a copy is no longer available on the market (e.g. Germany).

As for "not for direct or indirect economic or commercial advantage", countries have taken different approaches, too. As for the clause about making copies not for direct or indirect commercial advantage, some countries have limited the purpose of making copies to internal use where there is no economic advantage for the beneficiary. However, this ignores the fact that the beneficiaries such as libraries hardly use the works themselves, but by their purpose make information

accessible. Thus, the approach taken by Italy, referring to the “services of the said institutions,” seems to be more appropriate. One more question concerns compensation. Several countries do not provide for compensation for copies made under their implementation of Art. 5(2)c EUCD. Others require the compensation of right-holders through the distribution of levies (e.g. Germany). In analog environments, research, private use or specific library exceptions in copyright statutes around the world have permitted so-called document delivery services, either in the form of inter-library loan services or by sending copies of documents to individual users upon request. However, lawmakers across jurisdictions have generally been reluctant to extend these traditional limitations on copyright to digital content delivery.

The extent to which electronic document delivery is permitted has been contested in particular. As discussed above, Art. 5.2(c) EUCD allows member states to provide for limitations on the right of reproduction (Art. 2 EUCD). Recital 40 EUCD, however, states that Art. 5.2(c) EUCD “should not cover uses made in the context of on-line delivery of protected works or other subject matter” (assuming that electronic document delivery falls under the exclusive right of authors to communicate a work to the public, Art. 3 EUCD). On the other side, Art. 5.3(n) clearly permits the creation of an exception for document delivery to terminals located on the premises of the library or archive which serve research or private study. Yet, it has also been argued that Art. 5.3(a) EUCD might serve as a basis for both on-site as well as off-site online delivery of protected works provided that reproductions are made for research purposes. Others have argued that general private use and research exceptions may cover electronic document delivery. Given this unclear situation, explicit regulation about electronic document delivery is needed.

3.15.3 Exceptions for disabled people

As a consequence of Recital 36 in EUCD, which allows member states to provide for fair compensation also when applying optional exceptions or limitations that do not require such compensation, member states undertook different approaches as for the compensation for the use of works by the beneficiaries of the disability-exception.

In Germany, for instance, such uses generally have to be remunerated (compensation collected via collecting societies), except in the case of making individual copies. In other countries no fair compensation is required. One more problem concerns DRM systems. Most of the countries do not allow circumvention of DRM systems, even if the purpose is to make content accessible for people with disability. Some countries address this issue by requiring associations of right-holders to provide themselves for different access possibilities to protected works for people with disability. One more problem concerns distribution of copyrighted content to individuals or institutions in other European countries. This is not allowed by most of the national copyright laws.

4 DISTRIBUTION OF COPYRIGHTED CONTENT TO BLIND AND PARTIALLY SIGHTED

4.1 Negotiation with publishers: success experiences

4.1.1 Norwegian Library for the Blind

Norwegian Library for the Blind provides blind and partially sighted readers with books in accessible digital formats. NLB does not distribute through network services. NLB can distribute books in accessible digital formats thanks to agreements with LINO, an organization authorised by its members to administer the rights of writers in respect of literary works and is empowered by them to collect any income derived from licences negotiated and to disburse the said income. In order to be registered as a borrower at the NLB, documented proof of visual impairment or print disability must be submitted. All library services are free of charge. NLB has a special department dealing with all applications from visually impaired students and arranging for the production of the literature they require in connection with their particular curriculum. Students with print disabilities are free to loan books.

4.1.2 Server H el ene

Server H el ene has been set up for the French association BrailleNet since 2001 for the use by blind and partially sighted persons. Books in digital formats (most of all in DAISY, NISO Z39.86) are stored on the server. Users can have access to the server by subscribing and providing original certification of blindness or print impairment. Files are distributed to subscribed users through an access-controlled system. Users cannot redistribute themselves the files received because they are linked to a certificate generated for their own machine. Distribution and adaptation of books in digital formats such as DAISY or PDF for partially sighted readers are possible thanks to title-by-title agreements between BrailleNet Association and publishers. Every publisher has his own policy about author's right, Internet and digital reading. That means that books are available under different conditions. In particular, most agreements contain a clause concerning "distribution for the whole world". This clause can be applied only if the publisher has the rights to distribute the book outside France and agrees with distributing it in digital format for blind and partially sighted. At the time being, server H el ene does not produce scientific books for students.

4.2 Open Access Resources

In recent years, scientific communication has been going through several problems:

- serial pricing crisis: publishers almost totally control distribution of technological and scientific literature, access price for libraries and universities to scientific papers has been increasing more and more for years, funding for library services has been getting lower and lower for years so that few institutions are able to access scientific journals;

-
- permission crisis: new barriers limit access to journals (e.g. DRM systems), access control to online journals, etc.;
 - unsatisfied promises of recent technology: prices haven't got lower with online journals, but they have increased because of base-spend rules which let to sum prices for paper and online journals, limitations to citations because of controlled access.

Therefore, as observed by P. Suber, scientific communication is going toward restrictions in content spreading (P. Suber, "Removing the Barriers to Research: An Introduction to Open Access for Librarians": <http://www.earlham.edu/~peters/writing/acrl.htm>).

Open access can be a solution to some of these problems. Open access aims at improving scientific research by changing the modalities which are commonly used to spread scientific literature. The open access initiative took its first crucial step with the Budapest Open Access Initiative, on February 14th, 2002, (<http://www.soros.org/openaccess/read.shtml>). This document reports the basic concepts underlying open access:

"The literature that should be freely accessible online is that which scholars give to the world without expectation of payment. Primarily, this category encompasses their peer-reviewed journal articles, but it also includes any unreviewed preprints that they might wish to put online for comment or to alert colleagues to important research findings. There are many degrees and kinds of wider and easier access to this literature. By "open access" to this literature, we mean its free availability on the public internet, permitting any users to read, download, copy, distribute, print, search, or link to the full texts of these articles, crawl them for indexing, pass them as data to software, or use them for any other lawful purpose, without financial, legal, or technical barriers other than those inseparable from gaining access to the internet itself. The only constraint on reproduction and distribution, and the only role for copyright in this domain, should be to give authors control over the integrity of their work and the right to be properly acknowledged and cited. While the peer-reviewed journal literature should be accessible online without cost to readers, it is not costless to produce. However, experiments show that the overall costs of providing open access to this literature are far lower than the costs of traditional forms of dissemination. With such an opportunity to save money and expand the scope of dissemination at the same time, there is today a strong incentive for professional associations, universities, libraries, foundations, and others to embrace open access as a means of advancing their missions. Achieving open access will require new cost recovery models and financing mechanisms, but the significantly lower overall cost of dissemination is a reason to be confident that the goal is attainable and not merely preferable or utopian."

To achieve open access to scholarly journal literature, the Budapest open access initiative recommends two complementary strategies: self-archiving and open access scientific journals. Self-archiving refers to the opportunity researchers and scientists may have to deposit refereed journal articles in open electronic archives. When these archives conform to standards created by the Open Archives Initiative, then search engines and other tools can treat the separate archives

as one. Users then need not know which archives exist or where they are located in order to find and make use of their contents. The second strategy concerns launching of a new generation of journals committed to open access, and helping existing journals that elect to make the transition to open access. Because journal articles should be disseminated as widely as possible, these new journals will no longer invoke copyright to restrict access to and use of the material they publish. Instead they will use copyright and other tools to ensure permanent open access to all the articles they publish. Because price is a barrier to access, these new journals will not charge subscription or access fees, and will turn to other methods for covering their expenses. There are many alternative sources of funds for this purpose, including the foundations and governments that fund research, the universities and laboratories that employ researchers, endowments set up by discipline or institution, profits from the sale of add-ons to the basic texts, funds freed up by the demise or cancellation of journals charging traditional subscription or access fees. There is no need to favour one of these solutions over the others for all disciplines or nations.

The open access model has developed much through years. In 1990 the open access arXiv for physics papers was set up. In 1995 two remarkable open access initiatives were launched: WoPEc for economics, NCSTRL for computer science. In 1996 PubMed included Medline as open access archive. In 2001 the Public Library of Science (PLOS) was founded. In 2003 was released the Directory of Open Access Journals. In 2006 the European Commission issued a report in order to recommend open access for public research. In 2006, in the United States was approved the Federal Research Public Access Act of 2006 to recommend open access in federal research. In the same year at CERN was launched SCOAP3 to convert to open access particle physics journals. In 2007, the European Research Advisory Board issued a recommendation in using open access for European Union funded research. Also the European University Association recommended open access for collecting research results. The European Research Council issued the ERC Scientific Council Guidelines for Open Access which requires the deposit of papers and scientific data in open access repositories. In 2007, 427 scientific societies are publishing 496 scientific journal based on open access model. All over the world, graduation works and PhD thesis are more and more being archived in open access repositories.

In order to account for how many valuable scientific papers can be archived in open access repositories, the full process is illustrated.

At first research is done and a paper is written by one or more researchers.. Then pre-refereeing is done and a pre-print is submitted to a journal or for a conference and it is reviewed by peer experts. Based on the review report, authors revise their pre-print and submit the paper for publishing. The post-print is sometimes archived by the publishers and made available through online journals (researchers can access the post-print if their university has a subscription to the Journal). Authors are almost always free to archive in open access repositories their first draft as long as it is not refereed (because publishers haven't yet done some work on it). This may be useful, but not refereed and corrected works can be harmful for scientific learning and research. According to the publishers' copyright transfer agreements, authors are permitted to self-archive in open access repositories also: refereed pre-print, post-print (not necessarily in the format used for

publishing) or pre-print together with corrections made by referees in a separate document. At present, most scientific publishers, which distribute 90% of published scientific papers, allow for some kind of self-archiving. In appendix A, a list of publishers' self-archiving policies is reported. This list was drafted by collecting data from SHERPA project and Oaklist database. Further publishers were added by contacting them through publisher associations (e.g. Federation of European Publishers). For example, Elsevier, which publishes a large amount of scientific journals, permits authors to self-archive post-prints in their own personal pages as well as in institutional repositories. Published source must be acknowledged and a link to the journal home page must be present on the page. The final PDF file used for publishing can't be used, but the document in another format or with a different layout can be self-archived. Therefore, post-prints adapted in formats accessible for blind and partially sighted persons, can be archived in open access repositories.

5 CONCLUSIONS

In order to achieve transnational distribution of scientific documentation in digital accessible formats to people with visual impairment, issues concerning right holders have to be taken into account. In particular the following actions are proposed:

- case-by-case agreements have to be negotiated with right-holders. Model agreements can be developed and proposed to right-holders, based on success experience (see section 4.1);
- collaboration actions with publisher associations are needed both to make them better understand problems concerning access to digital resources for people with disability and to make specialist organizations acquire knowledge about publishers' policies and internal workflow;
- support open access publishing and collaborate with institutions which manage open access repositories. These repositories achieve transnational delivery of scientific document. By collaborating with institutions which manage these repositories in order to make available papers in accessible format would give the opportunity to blind and partially sighted persons to gain access to a great deal of accessible scientific papers;
- inform authors through scientific societies about the benefit of open access also for blind and partially sighted. Provide also authors with the guidelines in making accessible scientific content.
